

INTERMEDIATES

JUNIORS MUST HAVE PARTICIPATED IN THE GOLD HILLS JUNIOR GOLF CAMPS FOR 2 YEARS, BE AT LEAST TEN YEARS OLD BY THE START OF THE PROGRAM, AND BE APPROVED BY THE PROFESSIONAL STAFF.

JUNIORS MUST PROVIDE THEIR OWN BALLS, TEES, AND GOLF CLUBS WHICH INCLUDE 3, 5, 9, IRONS, 1, 3 WOODS, SAND WEDGE OR PITCHING WEDGE, PUTTER.

REGISTRATION FEE: \$175 PER JUNIOR

Fee includes: NCGA handicap card, discount green fees at Gold Hills and over seventy other northstate courses upon completion of Youth on Course Program. They will play each Tuesday at Gold Hills for 7 weeks starting June 14th. Juniors will be given a clinic on etiquette, rules and swing instruction before teeing off each Tuesday along with tips on the course while playing.

I/We understand that my/our child may be transported to and from various golfing events occurring at different locations, some of which will be outside of Redding, and that my/our child may be transported by employees of Gold Hills or other individuals and that TRANSPORTATION IN VEHICLES INVOLVES NUMEROUS RISKS OF INJURY OR DEATH, including without limitation, collisions and non-collision accidents, and I/We, on behalf of myself/ourselves and my/our child, freely assume those and any and all risks of my/our child's transportation as part of the Golf Camp.

As lawful consideration for my/our child's being permitted to enroll in the Golf Camp, I/We hereby agree, on behalf of myself/ourselves and my/our child, to RELEASE FROM ANY LEGAL LIABILITY AND AGREE NOT TO SUE THE GOLD HILLS JR GOLF CAMP, it's elected officials, officers, employees, agents and volunteers for any and all injuries, claims or liability by or resulting from or in - any way connected with my/our child's voluntary participation in the Golf Camp or the sport of golf or the transportation to and from various golfing events whether or not such injury or death was caused by alleged negligence or otherwise.
